Proposal 6. Proposed by Capricornia Cavy Club

A position of "Qld Judges Coordinator" who is responsible for:

- Keeping records of Trainee Judges
- Organising Trainee Judges Tests
- First point of contact between Trainees and the Judges Panel.

This position is NOT a position of power but a liaison between the QCC Secretary, Clubs and Trainee Judges. A lot of communication can be done via email as proven effective this year.

Proposal 7. – Proposed by Capricornia Cavy Club

At the end of the Trainees probationary year they should be required to sit a written exam plus a practical exam supervised by at least 3 qualified judges. This can be done at a show where there are enough available judges.

Proposal 8. – Proposed by Capricornia Cavy Club

A trainee pack to be put together outlining the ethics, rules, expectations and scheduled tests etc to that they trainee is comfortable in knowing what is expected of them. (In light of what has been going on with the trainees of late and them having to make contact to find out what is happening) If this isn't addressed why would anyone want to start training?

All 3 proposals addressed together as one.

<u>BCF would like to make an amendment</u> - Suggest that a panel of 3 judges be formed to work on organising trainee judges and report back to the club delegates in February so as the have a clear direction and to reduce the confusion.

- It is proposed that 1 judge be elected from each region Northern, Central and South Eastern.
- If no nominations are received from a region, that region may elect to pass their position onto another judge from a different region; otherwise they will forfeit their right to have a judge represent their region.
- The judge is to be a qualified judge with no less than 2 years out of their traineeship.
- Motion carried to have the matter voted on at a later date.
